









Who Are We

Vibrant Gastro's first indication is for treating adults with chronic idiopathic constipation (CIC) who have not experienced relief of their bowel symptoms by using laxative therapies at the recommended dosage for at least one month.



Company History



- Vibrant was established in Sep 2007 as a medical device company, with aim to evaluate the probability of pre-programmed mechanical stimulation as a treatment option for constipation.
- (2) At that time there was no literature, no previous research that supported this theory and how to approach it.
- Vibrant found itself pioneering a novel approach, with a need to conduct full research plan with CIC patients, in order to understand the various mechanical stimulation parameters that can actually improve the bowel movement symptoms and maintain high safety profile.
- During the clinical development process, Vibrant conducted various double-blind studies, exploring both mechanism of action and dosing of the treatment. The company conducted studies in USA with over 850 CIC patients, including a successful phase III study with over 300 patients.
- The company's investors and team committed themselves to develop a new treatment system and prove that working with the natural biological clock of a patient, can deliver significant clinical benefit to constipated patient, while improving their quality of life.

Conclusions In patients with chronic constipation, the vibrating capsule was superior to placebo in improving bowel symptoms and quality of life. The vibrating capsule was safe and well tolerated.



Effects of the vibrating capsule on colonic circadian rhythm and bowel symptoms in chronic idiopathic constipation, Apr 2020 Satish S.C. Rao, MD, PhD et al

Conclusions Vibrating capsule may increase CSBMs possibly by enhancing the physiologic effects of waking and meals, and augmenting circadian rhythm, although responder rate was not different from sham. Two vibration sessions were associated with more CSBMs.

Conclusions The Vibrant Capsule is safe and potentially effective in the treatment of constipation, justifying randomized controlled studies.

Conclusions Patients with CIC with >80% adherence to capsule dosing frequency had a superior response, supporting the appropriateness of the proposed dosing schedule

Conclusions Vibrant was found to be safe and well tolerated. No AEs of diarrhea were reported. 82-94% of study participants found the VC system easy to use and 85% were willing to try this treatment. The VC was found to be safe, well tolerated and easy to use in CIC patients.



Insights into Biology and Bioengeering Led to this Discovery

When we eat, food moves down the esophagus, into the stomach where digestion begins, then the largely liquid material moves on to the small bowel for more breakdown and absorption of things like vitamins and nutrients, before moving to the colon.

With the help of resident bacteria, the six-foot long muscular colon absorbs water, electrolytes and vitamins from the digesting food, which helps solidify the stool and pass it on to the rectum for elimination.

In states of good health, the colon is constantly contracting slightly to help move contents along, the movement, called peristalsis, should increase when food is actively being processed.

As one way to identify more effective therapies with less side effects, direct mechanical stimulation of the colon emerged as a possible strategy.



Unmet Need and How Vibrant works

- Despite advances in drug therapy, there is a tremendous unmet need for chronic constipation, a worldwide problem affecting about 40 million people in the US alone. About half of patients are dissatisfied with their current therapies and willing to try new ones, report study authors who included William D. Chey, MD from the University of Michigan in Ann Arbor, Anthony J. Lembo, MD, from Beth Israel Hospital in Boston and Dr. Amol Sharma, also at MCG and Augusta University Health.
- 2 Vibrant's drug-free treatment uses gentle vibrations to stimulate the colon mechanically.
- 3 The mechanical stimulation causes the colon to contract and effectively propel its contents.
- Vibrant's timed stimulation is optimized to deliver vibrations based on these alterations, which helps the colon contract mechanically in synch with its biological clock.
- Vibrant increases the number and frequency of complete spontaneous bowel movements, improves straining, stool consistency, and the quality of life, compared to placebo.
